THIS SUPPLEMENTAL AGREEMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT (as "SA#1") is made and entered into this 5<sup>TH</sup> day of September, 2017 (the "Effective Date"), by and between the MIAMI-DADE COUNTY EXPRESSWAY AUTHORITY d/b/a MIAMI-DADE EXPRESSWAY **AUTHORITY** (as "MDX"), a body politic and corporate, a public instrumentality and an agency of the State of Florida, created under the Florida Expressway Authority Act, Part I of Chapter 348, Florida Statutes, acting by and through its Governing Board, and WEISS SEROTA HELFMAN COLE & BIERMAN, P.L. (as the "Consultant"), a corporation duly organized and existing under the laws of Florida, F.E.I.N. 20-8112403 (collectively, referred to herein as the "Parties" to this SA#1).

### **WITNESSETH**

WHEREAS, pursuant to MDX Procurement/Contract No. RFQ-17-04, MDX competitively procured for Legal Services Support - Eminent Domain (the "Services"), and subsequently entered into a Professional Services Agreement with the Consultant on April 1, 2017 to perform the Services (the "Agreement" or "Contract"); and

WHEREAS, MDX now wishes to include a procedure for the Consultant to use the services of certain professionals as independent experts;

NOW THEREFORE, in accordance with §8.3 Approval Authority of Agreements and Supplemental Agreements of the MDX Procurement Policy in effect as of October 27, 2015 (publically available on the MDX website: www.mdxway.com and incorporated herein by reference and made a part hereof) and in consideration of the mutual promises and covenants contained herein, and for such other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

## **Independent Experts**

The Consultant may utilize the services of professionals in various industries to serve as independent experts as may be necessary for the Services (the "Independent Experts"). The Independent Experts are not Subconsultants to the Consultant and provide the required expertise in an unbiased and objective manner. When the need to utilize an Independent Experts arises, the Consultant shall follow the steps described in Section 11.3 of the Agreement using the Request for Approval of Independent Expert form.

- 3. The Request for Approval of Independent Expert form is hereby attached as Exhibit A to this SA #1.
- 4. The defined terms used herein, unless otherwise defined in this SA#1, shall have the meanings ascribed to them in the Contract Documents.
- 5. Except as expressly provided herein, all of the terms, conditions, covenants, agreements and understandings contained in the Contract Documents shall remain unchanged and in full force and effect, and the same are hereby expressly ratified and confirmed by the Parties.
- 6. This SA#1 shall not alter or change in any manner the force and effect of the Contract except insofar as the same is altered and amended by this SA#1. Wherever the terms of this SA#1 and the terms of the Contract Documents are in conflict, the terms of this SA#1 shall govern and control.

IN WITNESS WHEREOF, the Parties have caused this SA#1 to be executed by their respective and duly authorized officers as of the Effective Date set forth herein.
