THIS SUPPLEMENTAL AGREEMENT NO. 1 TO COOPERATIVE PURCHASING AGREEMENT ("SA #1") is made and entered into this 30 day of October, 2022 (the "Effective Date"), by and between the ***Miami-Dade County Expressway Authority d/b/a as Miami-Dade Expressway Authority*** (the "Authority" or "MDX"), a body politic and corporate, a public instrumentality created by the Board of County Commissioners of Miami Dade County as amended, acting by and through its Governing Board, and ***GUS MACHADO FORD, INC. (AS GUS MACHADO)***, a corporation organized and existing under the laws of the State of Florida, and duly authorized to transact business in the State of Florida, ***F.E.I.N. 59-2336101***, having its principal office at ***1200 W. 49TH Street, Hialeah, , Florida 33012*** (as the "Vendor") (collectively, referred to herein as the "Parties" to this SA #1).

WITNESSETH

WHEREAS, on April 18, 2018, City of Miami issued an Invitation for Bid, IFB Number 708382 (the "IFB"), for "OEM and Aftermarket Vehicle Parts, Services, and Repairs" which was awarded on November 15, 2018 to various vendors as the responsive and responsible bidders, on an as-needed basis, for an initial period of three (3) years with the option to renew for two (2) additional two (2) year periods; and

WHEREAS, pursuant to the MDX Procurement Policy, Section 4.7 "Cooperative Purchasing AND Piggy-Banking adopted on October 27, 2015 ("Piggy-Backing"), MDX entered into Contract No. MDX-20-02 with GUS MACHADO on October 30, 2019 for a period of three (3) years, with the option to renew in whole or in part, or increments thereto, for two (2) additional two (2) year periods; and

WHEREAS, MDX now desires to exercise the Agreement's renewal option to extend the contract through October 29, 2024.

NOW THEREFORE, in accordance with Section 8.3 "APPROVAL AUTHORITY OF AGREEMENTS AND SUPPLEMENTAL AGREEMENTS" of MDX's Procurement Policy, as well as consideration of the mutual promises and covenants contained herein, and for such other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties do hereby agree as follows:

1. The foregoing recitations are true and correct and are incorporated herein by reference.
2. The Agreement is hereby extended through October 29, 2024.
3. The defined terms used herein, unless otherwise defined in this SA #1, shall have the meanings ascribed to them in the Contract Documents.
4. Except as expressly provided herein, all of the terms, conditions, covenants, agreements and understandings contained in the Contract Documents shall remain unchanged and in full force and effect, and the same are hereby expressly ratified and confirmed by MDX and GUS MACHADO.
5. This SA #1 shall not alter or change in any manner the force and effect of the Agreement except insofar as the same is altered and amended by this SA #1. Wherever the terms of this SA #1 and the terms of the Contract Documents are in conflict, the terms of this SA #1 shall govern and control.
