Carlos R. Fernandez-Guzman Appointed to MDX Board of Directors

MIAMI, Fla., January 9, 2012 – Carlos R. Fernandez-Guzman, President and Chief Executive Officer of Pacific National Bank, has been appointed to the MDX board of directors by Governor Rick Scott.

Of the 12 volunteers, Florida's Governor appoints five of them and the Miami-Dade Board of County Commissioners appoints the remaining seven members.

MDX is funded almost entirely by toll revenue and is dedicated to moving Miami-Dade County forward making your commute safer and more efficient.
