SR 874/Don Shula Expressway

Complete Closures

All lanes on northbound SR 874/Don Shula Expressway at SW 93rd Street will be closed for sign replacement on **Saturday, March 30 and Sunday, March 31 from 11 p.m. to 8 a.m.**

Drivers should follow all posted detour signs. Detour information:

Motorists driving on northbound SR 874/Don Shula Expressway will:

- Exit at SW 88th Street and make a right at the light
- Continue driving east on SW 88th Street
- Make a left turn at the light
- Continue straight to access northbound SR 874/Don Shula Expressway and eastbound SR 878/Gratigny Parkway



Ramp Reduction

Up to two lanes on the southbound SR 874/Don Shula Expressway exit ramp to westbound Killian Parkway/SW 107th Avenue will be closed for sign replacement on **Sunday, March 24 through Friday, March 29 from 11 p.m. to 5:30 a.m. each night.**

Lane Closures

A single lane on northbound and southbound SR 874/Don Shula Expressway between Miller Drive and Kendall Drive will be closed for sign installation on **Sunday, March 24 and Friday, March 29 from 11 p.m. to 5:30 a.m. each night.**

Lane Closures

A single lane on northbound SR 874/Don Shula Expressway from Killian Drive to SW 109th Terrace will be closed for sign replacement on **Sunday, March 24 through Friday, March 29 from 11 p.m. to 5:30 a.m. each night.**

Lane Closures

Up to two lanes on southbound SR 874/Don Shula Expressway from SW 91st Terrace to SW 94th Street will be closed for sign replacement on **Sunday, March 24 through Friday, March 29 from 11 p.m. to 5:30 a.m. each night.**

Lane Closures

The two left lanes on the southbound SR 874/Don Shula Expressway exit to eastbound SW 88th Street will be closed for sign replacement on **Sunday, March 24 through Friday, March 29 from 11 p.m. to 5:30 a.m. each night.**

Motorists driving on southbound SR 874 wishing to access eastbound SW 88th street will:

- Take exit to westbound SW 88th Street
- Turn right onto SW 88th Street and continue straight
- Make a U-Turn at SW 99th Court access eastbound SW 88th Street

Street Lane Closures

Up to two lanes on westbound Killian Parkway from SW 103rd Lane to SW 102nd Avenue will be closed for sign replacement on **Sunday, March 24 through Friday, March 29 from 11 p.m. to 5:30 a.m. each night.**

The program is available between January 1 - June 30, 2024. Qualifying customers can earn a 20% SunPass discount when 40 GMX tolls are paid per calendar month - no registration required. GMX allocated \$10 million toward the South Florida Saves program in their 2024 fiscal year budget.
