Lane Closures

A single lane on westbound SR 924/Gratigny Parkway from NW 57th Avenue to SR 826/Palmetto Expressway will be closed for sign repairs on **Sunday, March 24 through Friday, March 29 from 11 p.m. to 5:30 a.m. each night.**

A single lane on westbound SR 924/Gratigny Parkway from NW 32nd Avenue to NW 57th Avenue will be closed for bridge repairs on **Sunday, March 24 through Friday, March 29 from 11 p.m. to 5:30 a.m. each night.**

Lane Closure

A single lane on eastbound SR 924/Gratigny Parkway from SR 826/Palmetto Expressway to NW 67th Avenue will be closed for drainage maintenance on **Sunday, March 24 through Friday, March 29 from 9 a.m. to 3:30 p.m. each day.**

The program is available between January 1 - June 30, 2024. Qualifying customers can earn a 20% SunPass discount when 40 GMX tolls are paid per calendar month - no registration required. GMX allocated \$10 million toward the South Florida Saves program in their 2024 fiscal year budget.
