**SR 836/Dolphin Expressway**

**Lane Closures**

The right lane on eastbound and westbound SR 836/Dolphin Expressway will be closed between NW 137<sup>th</sup> Avenue and Florida's Turnpike for barrier wall relocation on **Sunday, April 21 and Thursday, April 25 from 10 p.m. to 5:30 a.m.**

**Lane Closures**

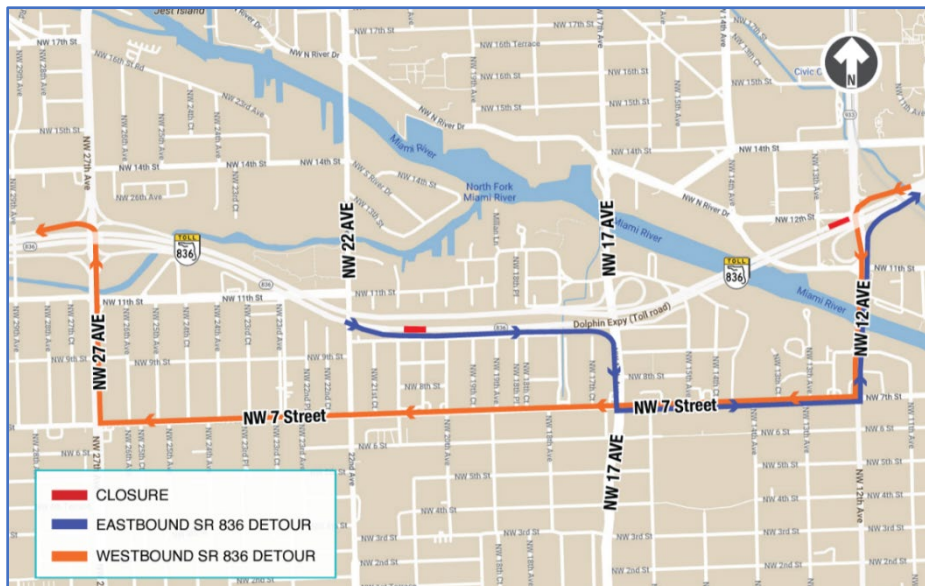
Up to two lanes on eastbound and westbound SR 836/Dolphin Expressway between NW 27<sup>th</sup> Avenue and NW 57<sup>th</sup> Avenue will be closed for bridge maintenance on **Sunday, April 21 through Friday, April 26 from 11 p.m. to 5:30 a.m. each night.**

The following closures are part of the I-395/SR 836/I-95 Design-Build Project. This schedule may change due to bad weather or other unforeseen conditions.

**SATURDAY, APRIL 20** – Two eastbound and westbound lanes on SR 836 from NW 17<sup>th</sup> Avenue to I-95 will be closed between the hours of **10 p.m. and 8 a.m.**

**SUNDAY, APRIL 21** – All westbound lanes on SR 836 will be closed from NW 12<sup>th</sup> Avenue to NW 17<sup>th</sup> Avenue between the hours of **10 p.m. and 5:30 a.m.** Drivers:

- Exit at the NW 12<sup>th</sup> Avenue ramp, then turn left on NW 12<sup>th</sup> Avenue
- Turn right on NW 7<sup>th</sup> Street
- Turn right on NW 27<sup>th</sup> Avenue and continue north to connect with the westbound SR 836 ramp

**SUNDAY, APRIL 21** – All eastbound lanes on SR 836 will be closed from NW 17<sup>th</sup> Avenue to NW 12<sup>th</sup> Avenue between the hours of **10 p.m. and 5:30 a.m.** Drivers can:

- Exit at the NW 17<sup>th</sup> Avenue South (Ballpark) ramp, then turn right at NW 17<sup>th</sup> Avenue
- Turn left at NW 7<sup>th</sup> Street
- Turn left at NW 12<sup>th</sup> Avenue to connect with eastbound SR 836 ramp

**SUNDAY, APRIL 21 THROUGH FRIDAY, APRIL 26** – Up to two lanes on eastbound SR 836 from NW 17<sup>th</sup> Avenue to I-95 will be closed as needed between the hours of **9 p.m. and 5:30 a.m.**

**SUNDAY, APRIL 21 THROUGH FRIDAY, APRIL 26** – Up to two lanes on westbound SR 836 from I-95 to NW 17<sup>th</sup> Avenue will be closed as needed between the hours of **9 p.m. and 5:30 a.m.**

**SUNDAY, APRIL 21 THROUGH FRIDAY, APRIL 26** – The eastbound SR 836 ramp to northbound I-95 will be closed as needed between the hours of **9 p.m. and 5:30 a.m.** Drivers can:

- Access the southbound I-95/NW 8<sup>th</sup> Street Ramp, continue south on I-95
- Exit at SW 7<sup>th</sup> Street/Brickell Avenue (Exit 1B), then turn left at SW 8<sup>th</sup> Street
- Enter the northbound I-95 ramp
